#### **Purpose**

To establish a number of Virtual Joint Centres to explore ways to sustain or improve current levels of crop production with lower energy inputs and reduced environmental impacts.

## Key aims

- To support innovative basic, strategic or applied research that will enable crop production to be enhanced in ways that make appropriate use of fertilisers (or potential alternative sources of nitrogen) to optimise yields, while maintaining the quality of soil, water and air, and reducing adverse impacts on terrestrial, freshwater and marine ecosystems
- To optimise farm practices and soil management to make more effective use of fertilisers and reduce losses of reactive nitrogen to the environment
- To improve the efficiency of nitrogen uptake or metabolism by plants
- · To enhance nitrogen-fixation in legumes or exploiting the potential of BNF in non-leguminous plants
